Example of Educational Excellence

The City of Marion and Marion CUSD #2 entered into an Intergovernmental Agreement at last night's board meeting to allow Marion Unit 2 Building and Trades program to construct two single-family homes on lots that are a part of the City's Midway Court Rejuvenation Project. 




