Maintenance Report

Buildings

Lincoln School: Construction Phase 2 is well underway in B and C hallways. The ceilings, lighting and HVAC units are being removed and the new HVAC system is being installed. The exterior of the building has been pressure washed in anticipation of installing new windows and replacing the brick where the old HVAC units were removed.

Jefferson/Pre-K: The lighting, ceilings and wall coverings are being removed from the Pre-K side of Jefferson. The boiler has been removed and piping and ductwork is getting prepped and ready for the new heating and cooling system.

Jr. High: All lockers from the West Gym locker rooms have been removed and the area is getting ready for new paint, lighting, flooring, lockers and restroom fixtures. Floor protection has been added to the wood floor to protect it from construction. The masonry contractor is tuck-pointing and replacing any bad bricks they find. The contractors are waterproofing the exterior of the West Gym as they prepare the walls for the new finish on the upper portion of the gym; it is called (EIFS) Exterior Insulation Finishing System. This will be waterproof and keeps us from having to replace bricks. Lighting, ceilings and wall heaters have been removed from the upstairs classrooms, hallways and Media Center areas. The ductwork that is to remain in place has been cleaned and insulated. New ceilings and lighting are being installed along with the new HVAC system. The East Gym floor is in the process of getting sanded and refinished.

<u>Custodial</u> - Building custodians are busy deep cleaning all facilities, trying to stay one step ahead of the contractors along with keeping up with sporting events and summer school.

Warehouse

Warehouse crew is trying to keep all our grounds mowed and manicured, they help with unloading any trucks that come in and deliver any supplies to schools as needed.

Maintenance

Maintenance crew is working on summer requests, work orders, preventive maintenance items and any emergency that may come about.

Superintendent's Report

Dr. Oates updated the Board on the on-going summer projects at Jefferson, Lincoln and the Junior High. He shared with the Board twenty new promethean boards have been purchased and are being distributed throughout the District. He made mention of the numerous camps and activities taking place across the District using the amazing facilities at MHS.

Assistant Superintendent Report

Mrs. Moss stated summer school will conclude this week and has been a success. She reported promethean boards are being assigned to classrooms across the District and the K-5 Math Committee has met and anticipates making a selection for new curriculum this fall. She informed the Board she has been working with the Regional Office of Education on planning professional development workshops for the 2022-2023 school year.
