Technology Report

Jerry Stanley, Technology Director, reported to the Board a new student management system, Infinite Campus, is being launched for the 2022-2023 school year. The new program is an improvement over the prior program which had been in use since 2008. Dr. Oates complimented Jerry and his staff for a job well done preparing the faculty and staff for the change as well as for all the behind the scenes work it takes to make a change of this magnitude.

Maintenance Report

Jeff Moake, Maintenance Director, updated the Board on the ongoing summer projects at Jefferson, Lincoln and the Junior High.

Buildings

Lincoln School: Classrooms are being painted and floors are being installed where unit ventilators were removed. Window contractors are removing old windows and installing the new windows. Brick masons are repairing the metal on top of the windows and filling in exterior walls where the unit ventilators were removed. HVAC contractors are running piping as well as setting the new units.

Jefferson/Pre K: Ceiling, lighting and paint work is being completed in classrooms and corridors, boiler and HVAC contractors are in the cafeteria, office/media center and Pre-K area.

Jr.High: HVAC, plumbers, painters, masons, flooring and ceiling contractors are busy completing work in the West Gym, Main Office, upstairs classrooms, media center, and four classrooms on the East Side as well as exterior work waterproofing and working on tuckpointing and replacing some bricks.

Sports Complex: Concrete crews are at the Sports Complex pouring new sidewalks along the interior of the track for ADA compliance purposes. They are also pouring new paths on the North and East side of the Baseball/Softball Fieldhouse.

Superintendent's Report

Dr. Oates stated preparations are being made to welcome faculty back on August 8th for the 2022-2023 school year. He thanked faculty and staff for their overall cooperation for providing summer school to students and for their participation in training during summer break.

Assistant Superintendent Report

Becky Moss, Assistant Superintendent, reported summer school has concluded and was successful for all grade levels. There were 268 elementary students who successfully completed summer school. She reiterated Dr. Oates in regards to faculty and staff for their cooperation in providing summer school for students and their participation in training.

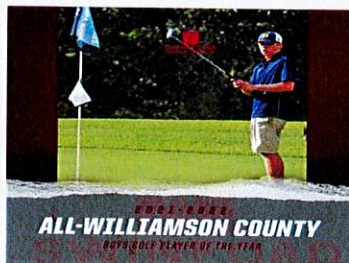
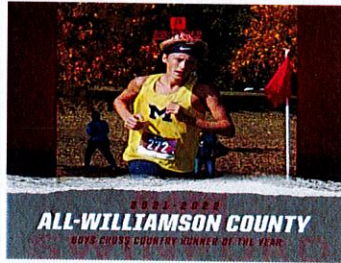

Motion #14 It was moved by Steve Cook and seconded by John Barwick to adjourn the meeting at 7:17 p.m. Motion carried.


